Dr. Akinwumi Ayodeji Adesina, MS '85, PhD '88, received an honorary doctorate in agriculture during the Purdue University commencement exercise Friday night (May 15) in the Elliott Hall of Music.



Dr. Akinwumi Ayodeji Adesina is Nigeria's Honorable Minister of Agriculture, and the country's governor and board member of the International Fund for Agricultural Development (IFAD). After earning his masters and doctorate degrees in agricultural economics from Purdue, Dr. Adesina dedicated his career to improving the agricultural sector in Africa.

Since his appointment as Minister of Agriculture in 2011, Dr. Adesina has flipped Nigeria's agriculture sector from one of subsistence farming into a viable business for the country's farmers. He halted a 40-year pattern of corruption in the country's fertilizer sector by developing and implementing an innovative electronic wallet system, which directly provides farmers with farm subsidies via their mobile phones. To date, this system has dramatically transformed the lives of 14.5 million Nigerian farmers. Under Dr. Adesina's leadership, Nigeria's food production has expanded by 21 million metric tons, and the country has received \$5.6 billion in private sector investments in agriculture.

Previously, Dr. Adesina served as vice president for policy and partnerships at the Alliance for a Green Revolution in Africa (AGRA). Working with Heads of State and finance ministers, leaders of the commercial banking industry, and central bank governors across several African countries, Dr. Adesina successfully led one of the largest global efforts to leverage domestic bank finance (\$4 billion) for the continent's agricultural sector.

Prior to joining AGRA in 2008, he served as associate director and then regional director for the Southern Africa Office of the Rockefeller Foundation for more than a decade. He also served on the Technical Board of the Forum for African Women Educationalists, as a principal economist for the West Africa Rice Development Association, senior economist and social science coordinator for the International Institute for Tropical Agriculture, and assistant principal economist for the International Crops Research Institute for the Semiarid Tropics.

Dr. Adesina is a prolific writer, with more than 70 scholarly publication credits on policy, agricultural development and African development topics, and has served on the editorial boards of several academic journals. Dr. Adesina also serves on the Global Panel on Agriculture and Food Systems for Nutrition, launched at the 2013 G8 Food and Nutrition Summit.

He has received numerous awards for his work, including the Outstanding Black Agricultural Economist award from the American Association of Agricultural Economists; the prestigious YARA prize in Oslo, Norway; Commander of the Order of Niger, the country's second highest honor; the Distinguished Alumni Award from Purdue University; and, most recently, the Forbes Africa Person of the Year award in 2013.

Dr. Adesina earned his bachelor's degree in agricultural economics from the University of Ife in Nigeria in 1981. He has lived and worked extensively in 15 African countries throughout West, East and Southern Africa.

Thought you would like to know:

Purdue's Morrill Awards were given Tuesday (May 5) at the Faculty Awards Convocation to three professors whose careers have demonstrated excellence in their teaching, research and engagement missions, as well as in demonstrating synergies among them.

This is the fourth year of the Morrill Award, initiated to honor the Morrill Act of 1862, which allowed for the establishment of land-grant colleges and universities. The award comes with a \$30,000 prize, which may be used as discretionary funds or salary supplements.

The 2015 Morrill Award winners:

Gebisa Ejeta, Distinguished Professor of Plant Breeding & Genetics and International Agriculture

Michael R. Ladisch, Distinguished Professor of Agricultural and Biological Engineering

Wallace Tyner, the James and Lois Ackerman Professor in Agricultural Economics

Tyner is widely regarded as the leading analyst of U.S. energy economics policy. His clear vision of the field, bolstered by his undergraduate degree in chemistry, has allowed him to address the economics of biofuels in the 1970s and delineate the connection of energy economics with agricultural economics by 2008 -- framing the issues before others recognized them. All along, he has communicated his findings broadly and effectively, from industry and government leaders to Purdue Extension publications. His voice is sought for his insights and his policy recommendations.

An early Peace Corps volunteer, Tyner also has maintained a global outlook that has led to work in 15 countries, in particular assisting Morocco for years starting in 1985. His steady, thorough knowledge and policy skills continued to develop, and in the past decade he has been asked to chair numerous panels, including a National Academy of Sciences report on the Renewable Fuel Standard. At Purdue, he has mentored over 60 graduate students and he has pursued interdisciplinary approaches to many of the subjects he has studied. He also served as chair of the Department of Agricultural Economics for 13 years, building its strength and reputation.

McNamara received a 2014 U.S. Department of Agriculture Secretary's Honor award in the Global Food Security category. The award citation reads: "For enhancing food security and improving the quality of life for thousands of farmers by building capacity in Afghanistan's agricultural extension system."

Jill Hufford was the recipient of the Business Office Service Award.

News from the Center for Global Trade Analysis

The [Center for Global Trade Analysis](#) based at Purdue University released the latest version of its GTAP Data Base of worldwide economic transactions Tuesday (May19).

The ninth version incorporates global economic flows for the year 2011, the most recent available year for such data, while retaining important data from 2004 and 2007. A new version is released every five years.

"This is a critical tool for governments and economic decision-makers around the globe," said [Dominique van der Mensbrugghe](#) (pronounced MENZ'-broo-gah), director of GTAP.

The data influences policymaking on regional and global trade and environmental agreements such as the Trans-Pacific Partnership and international efforts to limit global greenhouse gas emissions, noted [Thomas Hertel](#), executive director of GTAP. It also is used by international institutions, the private sector and economists at universities and research institutions.

"Given that it also includes physical datasets like energy volumes and emissions, this database has been increasingly popular among engineers and scientists across the world," Hertel said.
