News from Center for Food and Agricultural Business Programs

The Center for Food and Agricultural Business will launch three new professional development programs in 2017: Cultivating Resilience, the Accelerated Management Program, and Turning Trust to Loyalty. See the program lineup at http://agribusiness.purdue.edu/seminars-and-events.

The American Seed Trade Association Management Academy is March 6-10 in Krannert Center. This year marks the program's 30th anniversary and 30 years of partnership between the center and ASTA. The management academy brings together 50 seed industry professionals for a week of top-notch instruction, networking and industry exposure. It is the center's longest running program.

The center and <u>Aspyre Growth Accelerator</u> will continue to partner in 2017, offering two programs in Johannesburg, South Africa. Agri-Finance for Non-Financial Managers is May 22-26, and Strategic Agribusiness Management is May 28-June 1.

Land O'Lakes Living Case

The center co-hosted the inaugural Land O'Lakes, Inc., Living Case Competition at Purdue University, Feb. 24-27 alongside the Krannert School of Management. Teams of undergraduate students visited a farm, toured a farmer-owned cooperative, and conducted interviews with representatives of Land O'Lakes Sustain and WinField United.
